

a. Why you are interested in the position?

I believe a board position is an opportunity to make a positive impact on a mission you value, while collaborating with others to further it. Over the last few years, my family has grown in our appreciation for Addenbrooke Classical Academy, and we see the invaluable opportunities it provides to children in our community. b. What do you believe classical education is, and why is it important?

Classical education forms both the mind and character of a child. It is not limited to the memorization of facts, but teaches students how to learn, how to wonder, and how to seek truth. By engaging with history, philosophy, literature, and the arts, students not only acquire knowledge but also cultivate wisdom. c. What do you believe the difference is between a governing board and a managing board?

Its focus is on strategic direction, policy, and oversight. A managing board, in contrast, is more involved in day-to-day operations, directly addressing tactical and immediate needs. The governing board collaborates closely with leadership, while a managing board would work more directly with staff on implementation.

d. What do you believe are the strengths and weaknesses of Addenbrooke Classical Academy?

A key strength of ACA is its ability to meet students where they are, using thoughtful scheduling and specialized classes to allow teachers more personal engagement with each child. The school's emphasis on the fine arts, alongside a commitment to classical education, enriches student formation by integrating creativity and wonder into the academic experience. Another strength is ACA's balanced approach to tradition and innovation, using technology when appropriate without compromising the classical model.

A current challenge is the rapid growth of the K–8 student body. While growth is a sign of ACA's strong reputation, it has created strains on physical space and staff capacity. Addressing these

challenges will be important to ensure that the quality of formation and community life remains strong.

e. What skills or expertise do you bring to the position?

This would be my third board position. I served on the board and eventually as the Managing Director of L'Alto Catholic Institute, where I oversaw daily operations and helped guide strategic growth. I currently serve on the board of the SOLT Family Mission Experience, supporting family-based mission work. Through these roles, I have developed experience in nonprofit governance, strategic planning, and ensuring organizations remain faithful to their mission. As a critical care nurse for over a decade, I have learned to advocate for others, collaborate in high-stakes environments, and listen carefully to diverse perspectives. Board Member Application Questions

a. Why you are interested in the position?

I'm interested in becoming a member of the Addenbrooke Classical Academy school board because I believe in the mission of the school. I am thankful every day that I have the opportunity to send my children to a school that has the convenience of a public school, but fosters classical thinking. I believe the ACA school board is one of the most integral parts of raising our children. We are allowed to teach our children truth at home without having the actions of others undermine our values. The integrity of this board is what makes ACA work for a lot of families. The board needs to continue to have people who uphold those values and I am someone who will do that.

b. What do you believe classical education is, and why is it important?

Classical education is important because it teaches children to think. It teaches them that there are truths in the world. This is a wild and crazy world. Everyone needs to be able to discern what is true and what that means. Children need a solid background in quality literature, mathematical ideas, and critical thinking skills. The current mainstream ideologies teach children that they can impose value on anything and cause any ideas to be true. A classical education gives children the background to understand where true value lies. It teaches children how to use a knowledge base to discover truth. Then, they are able to apply that truth to their lives and not be afraid to do hard things, if the truth does not align with their own thinking.

c. What do you believe the difference is between a governing board and a managing board?

A managing board does more work acting as administration. That means they make sure the day-to-day work is being done and they have a hand in actually enforcing what is going on in the school. A governing board makes decisions that are then passed down to the administration. The governing board does more work keeping the integrity of the school in place by setting policies. Then they can trust the administration to be the ones making change on the "ground floor."

d. What do you believe are the strengths and weaknesses of Addenbrooke Classical Academy?

The biggest weakness of ACA would have to be teacher turn over. In the past year, it seems that we have lost a lot of teachers mid-year, and that can be very hard for students. I understand the principals are committed to preforming exit interviews, and I'm hoping they can find viable solutions to encourage teachers to (at least) complete their year-long commitment.

The biggest strength of ACA is the tight knit community. It is clearly understood that the majority of families that go to ACA are looking for an alternative to public school education. This makes it so easy to create community with other families that support a quality educational experience for their children.

e. What skills or expertise do you bring to the position?

I have worked in public and private schools. I was a student teacher in a middle school and have taught up through college age students. I have a background in leadership positions with educational institutions. I have a background in science and math. I'm a mother of four children, and an active member of the ACA community. I have a strong faith background and I try to encourage the pursuit of truth, beauty, honesty, and integrity in my own home. I love the Charlotte Mason principles and the classical school model. To the Members of the Governing Board of Addenbrooke Classical Academy,

While growing up in Colorado, I was lucky to have many wonderful opportunities throughout my childhood. I cherish the sports, the hikes, the summer camps, the mountain trips, and all the rest. But as I grow older, I have come to more deeply appreciate the education I received as a child as I realize how it has served me. As a parent, I feel a responsibility to pay forward those same opportunities to my own children and to the community as a whole. This sense of stewardship led to my involvement as a volunteer coach for my daughter's soccer and tee ball teams. I view serving on the Governing Board of Addenbrooke Classical Academy as another great opportunity to give back to the community and foster the next generation.

I was fortunate to experience a Jesuit education myself, and I believe that it shares many of the same values as a classical education. Both emphasize developing virtuous, well-rounded individuals. During my education, I learned how to apply my lessons to new and changing scenarios. What I view as a strength of Addenbrooke, and what drew me to the school when deciding where to send my children, was the emphasis on the Socratic Method. The Socratic Method emphasizes a questioning mind, logical reasoning, discussion, and collaboration from multiple perspectives. I use this approach daily when coaching younger team members or when working with clients to develop a best solution when there is no clear answer. I believe these skills are invaluable, and will only be more valuable as new technologies develop and change the skills necessary to navigate society. A classical education will provide students the foundational skills they need to succeed in their endeavors throughout their lives.

In my view, my role on a governing board would be to provide guidance on major strategic initiatives, while also allowing management the space to implement those initiatives. While a governing board performs monitoring and oversight, management utilizes their expertise to execute the operations of the organization. This is in juxtaposition to a managing board that would be more heavily involved in the actual managerial functions and day-to-day operations of the organization.

While new to Addenbrooke, I believe that I can provide a fresh perspective while serving on the Governing Board. As a CPA, I have a high level of financial literacy that I believe would be valuable in monitoring budgets and fiscal results. As a professional, I have a strong sense of mentorship, and have served as a performance management leader and mentor for dozens of individuals in my career.
