

Executive Director Report March 8, 2022

- Enroll Jeffco (the system used for enrolling 2022-23 students) is continuing to have problems.
 Our Registrars, Amber McMaster, Ericka Horton and Amanda Jerome have been through multiple
 training sessions with Jeffco. While the folks at Jeffco have been kind, we are still struggling to
 see exact enrollment numbers. Currently we are projecting 850 students.
- 2. Kari Michelsen has headed up contacting and holding enrollment meetings with all of our 8th grade students and parents. Currently we have 18 not returning and about 19 who have yet to schedule a meeting.
- 3. The Capstone schedule has been published for the students, Board of Directors and Lakewood Council members. Currently, two Lakewood Council members have signed up to be part of the panel. I am going to reach out to some county judges to invite them to participate also.
- 4. On March 9th from 12:00-2:00 PM Evelyn Fiadonu will be at The Academy of Charter Schools in Westminster to learn about the systems and processes that they have in place.
- 5. The Parenting Safe Kids professional development morning with the entire staff was held on Friday, February 18th from 9:00 to 11:30 AM. The staff was moved by the presentation and asked many questions. I did not give the staff an extensive heads up about the program, and I believe a few might have been caught off guard. I met with a team of moms and Board Member Sarah Rodriguez on Thursday morning to discuss how to bring this to our parent community in the most effective way.
- 6. Don Moseley with Ralston House confirmed a parent training on Thursday, April 28th at 6:00 PM. The committee is looking for ways to invite Denver Christian parents to join us for the training.
- 7. An additional reminder that the Board of Directors visitation day is scheduled for Wednesday, March 9th. We will gather at the PreK-8 at 8:00 AM and then transfer to the High School at 9:30 AM. The administration will then serve you lunch at 11:00 AM.
- 8. We are moving forward with the following schedule for the High School (2022-2023): MWF will be eight-period days, which will include one period of Advisement. Tuesday and Thursday will be block days with Periods 1-4 on Tuesdays and Periods 5-8 on Thursdays.
- Staff letters of intent have been returned, and we currently have two teachers from the High School and seven teachers from the K-8 that will not be returning to Addenbrooke in the Fall of 2022.
- 10. Finally, we are working on a reasonable and lean budget for the 2022-2023 school year. The CDE and Jeffco have committed to a proposed PPR amount for next year of 9,270.99. We are budgeting in two ways: student enrollment of 800 and student enrollment of 850. We are also budgeting on an amount of 9,000.00 PPR and not the full projected amount.
