A quorum of the Board was present as follows: Mr. Chris Kuetemeyer President; Mrs. Stephanie VandenBerg Treasurer; Mrs. Lea Buck Community Board Member, Secretary; Mr. John LaBarbara, Community Board Member; Mr. Charles Wright Executive Director; Mrs. Julie Spencer, Principal. Mrs. Sarah Rodriguez, Director, was absent.
  - c. Public Comments. Ms Carpenter discussed with the board the development of the ACA Parents Facebook page.

  - e. Approval of Agenda.

- 2. Administration/Board of Directors Discussion Items
  - a. General Updates
    - i. Soccer field construction
      - 1. Almost done, should be done by next Friday!
    - ii. High School construction
      - 1. Basically complete. Just finishing the last details.
    - iii. Final count enrollment
      - 1. 855 FTE students; probably 857-860 students total.
      - 2. Grew by 70 students from last school year.
      - 3. Largest senior class yet, 45 students. 204 total in high school
    - iv. Charter Renewal Application update
      - 1. Draft renewal turned in.
      - 2. Final application will be turned in November 1<sup>st</sup>. Nov 4<sup>th</sup> is when application will be officially presented to Jeffco Board. Dec 10<sup>th</sup> will go before Jeffco Board for discussion
      - 3. We have been rated "Performance," which is highest rating, for past 5 years, for our fantastic school performance, budget, facilities, etc.
      - 4. Voting February 4<sup>th</sup> to approve 5-year renewal.
    - v. Year-to-Date Budget update
      - 1. Originally projected 915 students. So about 55 students short of goal.

- 2. PPR was reduced by 5%, due to COVID. \$7900 per student (down from \$8400). Capital construction money was reduced by 25%. So roughly \$400000 reduction in funding, plus \$450000 from reduced number of students.
- 3. Budget will likely remain in the black. CARES act will be helping with COVID-related learning needs (webcams, TVs, etc).
- vi. Traffic update
  - 1. Meeting between ACA and DC reps, as well as DPD and LPD, to determine if anything can be done about traffic around Mansfield and Teller
  - 2. "No Parking" signs M-F will be in place. 4-way stop signs will be in place.
